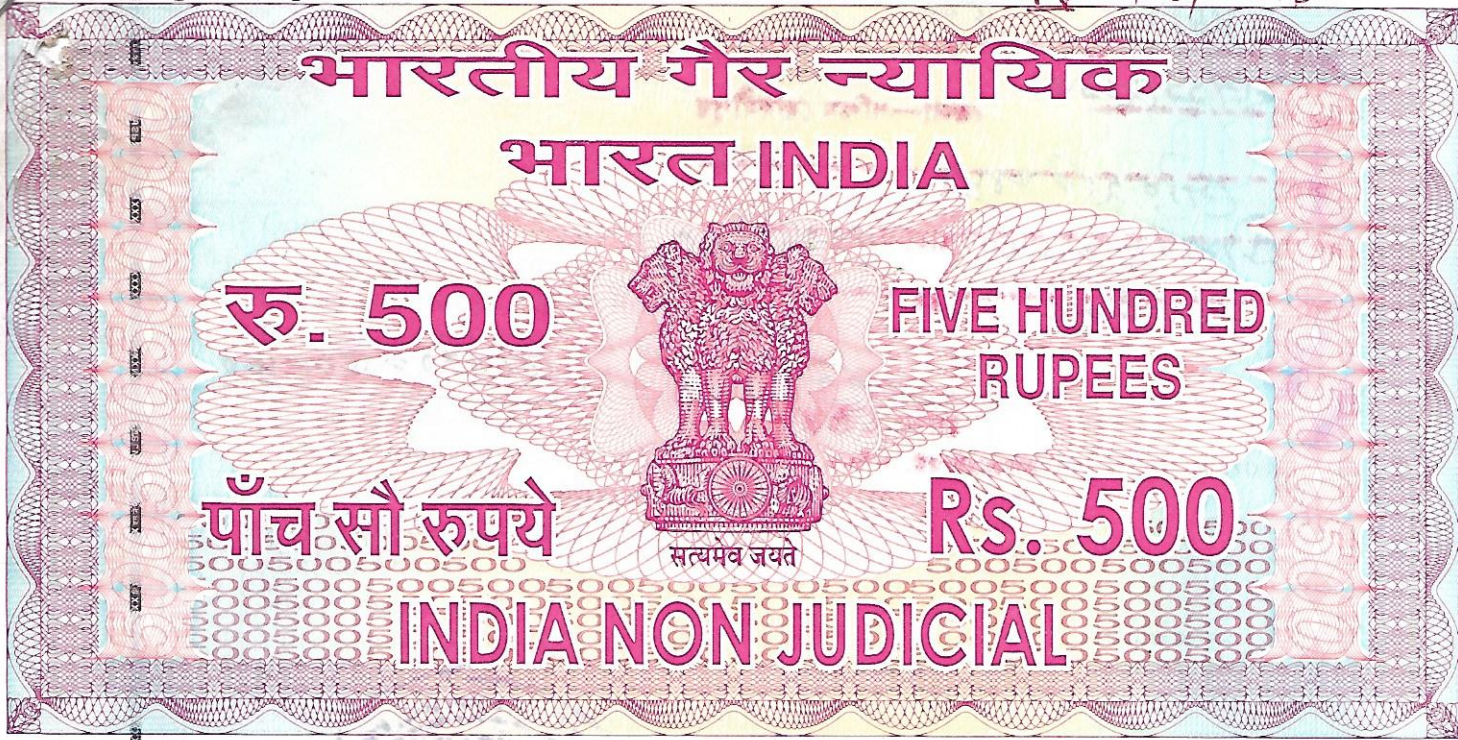

- iv) To promote, advance and encourage and/or aid in helping promoting, advancing and encouraging primary, secondary and higher education including technical and medical education, dental also physical training, all types of training institutes and/or colleges including teachers training colleges for the benefit of the minority students and the students belongs to all other communities, training of handicrafts, fine art and other useful arts, crafts among the public including the establishment and maintenance of Shilpa-Shikshalayas, Kala-Kendras and other welfare centers for them.

v) To foster and encourage education and training in handicrafts, fine arts.
