Sub: Temporary Affiliation of 2-Year B.Ed. Course to Kazi Nazrul Minority College of Education from the academic session 2016-2017.

Dear Sir.

I have been directed to inform you that on receipt of the recognition letter of N.C.T.E (F. No. ER-213.6(1).221/ERCAPP 3431/B. Ed./2016/46092, Dated 02.05.2016) and subsequently the approval letter of the Higher Education Department, Govt. of West Bengal (No. 639(8)-Edn(cs)/10M-53/15 dated 10.07.2015, the Working Committee constituted by the Eighth Executive Council of Vidyasagar University in its meeting dated 13.07.2016 has considered the Inspection Report submitted by the duly constituted Inspection Team regarding extension of temporary affiliation for conducting 2-Year B.Ed. Course to Kazi Nazrul Minority College of Education, Vill-Basudebpur, PO-Lakshmichak in the district of Paschim Medinipur which will run the course from the academic session 2016-2017 subject to the fulfillment of the following terms & conditions.

## The terms & conditions of affiliation of the above course:

The intake capacity at the initial stage for the above metioned course is 50(1 unit)

2. Students will be admitted purely on merit basis and the admission be made by the University centrally through counseling.

 The College must have to maintain 200 (two hundred) working days in each academic session.
At least 1 (one) whole-time qualified teacher in each subject is to be appointed immediately on receipt of the affiliation letter. Joining letters to be submitted to the University within 15 days alongwith a declaration that they are not engaged in any other institution.

5. At least 07 (seven) full-time contractual teachers, excluding the Principal, are to be appointed before commencement of the said course as per the norms of the NCTE (2014).

6. The full time Principal of the College must be appointed as per the norms of the NCTE (2014)

7. The college must abide by the Vidyasagar University Act, Statutes, Ordinances, Regulations etc. as aniended from time to time.

8. The college must abide by the norms of the N.C.T.E. in this connection.

9. The college must build up a Reserve Fund of Rs. 20,00,000/- (Rupees twenty lakhs) only within one year. 10. Books & Journals worth Rs. 1,00,000/- (Rupees one lac) only (both for English and Bengali version) for

different subjects as per the revised syllabus are to be procured by the college.

11. Subscription of Journal (at least Five Journals) are necessary. 12. Play Ground and facilities for outdoor and indoor games to be developed at the earliest.

13. Facilities for cultural activities to be created and maintained by the college.

- 14. Rs. 1,500/- (Rupees one thousand and five hundred only) per student per annum to be deposited by the college to the affiliating University.
- 15. In addition to the existing laboratory equipments, more equipments for different laboratories (Science Lab., Geography Lab. and Psychology Lab. Etc. are to be purchased. Adequate number of Computers and other Lab. Equipments are to be purchased. Necessary infrastructural facilities like bench, desk, chair & tables are to be developed.

16. School based subjects should be included as per N.C.T.E. norms 2014.

17. An one-time affiliation fee along with the Sports fee and renewal fee etc. is to be paid to the University per year as per the norms of the University which will be communicated later on.

Separate class rooms for method subjects are to be provided.

- 19. Common room will have to be provided for the students.
- 20. The college/Institution will provide 10(ten) internship (practice teaching) School name within 10-15 K.M. distance from the college/institution at an early date.

21. An undertaking on a Non-Judicial Stampof Rs. 50/- as per the prescribed proforms available in the office of the Inspector of Colleges is to be made by the college authority regarding abiding the Rules and Regulations of the University in this regard.

22. The affiliation of the University shall remain valid so long as the college enjoyes the recognition of the N.C.T.E.

23. The college will have to submit a compliance report to the University after fulfilling the above conditions on receipt of which formal affiliation will be extended.

An early reply accepting the terms and conditions of granting affiliation of the above mentioned course at Kazi Nazrul Minority College of Education should reach the undersigned within fifteen days from the date of receipt of this letter with a copy to the Inspector of Colleges.
